INFORMATION AND RATES

CRYSTAL COAST BOATWORKS is operating True World Marine Boatyard. We have an 11-acre boat service and repair yard located six miles north of Beaufort, NC on the ICW near mile marker 197.5. Our yard provides the following services: boat haul out with a 75 BFM II Marine Travelift, short and long-term boat storage, pressure washing, painting, fiberglass repair, master carpentry and other repair and service related work. This is also a do-it-yourself-yard. Sub-contractors are welcome and are required to sign in at each visit. Their proof of liability insurance must be on file with our office. All bottom painting will be done by a CCB crew-no exceptions.

NORMAL OFFICE HOURS OF OPERATION

Service and Repair Yard: Monday – Friday 8:00 am - 5:00 pm

Saturday 9:00am – 12:00 pm (with appointment)

1. Haul Out, Pressure Wash, Block and Launch:

We have a 75-ton Marine Travelift (165,000 lb. capacity). A Steel Beam is available to use upon request. We can use up to six slings when needed (additional charge for setup for 6 slings)

Haul, wash, block & launch	Power/Sail	\$ 11.00 per foot
Haul, block & launch	Power/Sail	\$ 8.50 per foot
Haul, wash, hold & launch	Power/Sail	\$ 9.50 per foot
Haul, hold and launch	Power/Sail	\$ 8.50 per foot

Travel lift pier width: 19' 10" Vessel beam maximum: 19'

Pressure washing and scraping on hulls with exceptional growth will be billed extra at \$60.00 per hr. First hour of Holding twill be no charge, and after \$50.00 per hr.

2. Labor Rates:

The following rates are applicable for regular service and repair work. We can give a quote for most jobs upon request. Overtime upon request will be 1.5 times the regular rate.

Detailing, Prep work, Sanding,	\$60.00 per hour + materials
Bottom Painting, Buffing	
Spray Paint, Fiberglass Work,	\$75.00 per hour + materials

3. Service Vessel Lay Days with CCB service contract:

No storage fee while CCB is working on your boat. After work is completed storage rates will apply.

Vessels remaining at the facility more than 48 hours upon completion of work will be billed at regular storage rates until departure (electrical power is not included).

4. Vessel Storage Rates in boat yard (storage only):

- \$ 1.00 per ft. per day
- \$ 3.00 per ft. per week
- \$ 7.00 per ft. per month

Long term storage is available at a reduced rate. Call or visit for details.

5. Do-It-Yourself Vessel Lay Days in boat yard:

- \$ 1.00 per ft. per day
- \$ 4.00 per ft. per week
- \$ 12.00 per ft. per month

Contractors/Subcontractors*: A Yard Use Fee will be billed directly to the boat owner for each Contractor & Subcontractor & their staff per each working day on the yard:

- 1 - 4 hours = \$18.00
- 4 - 8 hours = \$36.00

All contractors/subcontractors must sign in and sign out at the head office prior to performing any work on the yard.

*All contractors/subcontractors are required to have a current liability insurance certificate on file with our office. No sandblasting or spray painting is allowed by owners or owner's contractors/subcontractors unless approved by CCB staff. No outside lifts or cranes are allowed without our permission. A clean-up fee may be assessed if work area is not kept clean.

Some of the major Yard policies:

1. All bottom prep & paint work will be done by yard personnel.
2. Pets must be kept on a leash and must be cleaned up after.
3. No auto driving, working or storage on any grass areas.
4. Keep the area clean around your boat.
5. All cars/vehicles must abide by the 5mph speed limit for dust control and personnel safety.
6. No spray painting without yard approval.
7. Boat owners must secure their vessel prior to a storm: doors, hatches, port lights, loose items, etc.
8. Boat owners/captains must inform their contractors to sign in before they begin any work on the vessel.

CCB is not responsible for maintenance checks on stored vessels unless specific arrangements are made with the CCB staff.
